# THE QUESTION **FLOODING OUR INBOX:**

With the UK government's new immigration white paper released, international students especially those from South Asia, Africa, and Southeast Asia — are once again holding their breath. Will the Post-Study Work (PSW) route survive another policy cycle? Will it become more exclusive, or worse, vanish entirely?

Let's be clear from the start: the Graduate Route is still here. But it's under serious review. The white paper doesn't introduce immediate changes, but its tone says a lot. The government is keen to reduce net migration, and international students, particularly those bringing dependants or enrolling in lower-ranked institutions are increasingly viewed as part of the "problem."

Ministers are now asking: Are international graduates finding real jobs after their degrees? Are they contributing to the economy in a meaningful way? Or are they using the Graduate Route simply to extend their stay?

## **IS THE GRADUATE VISA SAFE?**



This is the crux of the policy pressure. The PSW visa, once celebrated as a step toward inclusivity and global talent retention, is now being scrutinised as a possible loophole and that scrutiny could mean a future tightening of rules, or selective restrictions based on subject, institution, or even nationality.

#### What Does This Mean for Students?

If you're already in the UK on a student visa, you are still eligible for the Graduate Route as long as your course and institution meet the usual criteria. Nothing has changed yet — but the uncertainty now shadows every future intake.

Universities are worried too. Institutions that rely heavily on international tuition may face pressure to "clean up" their admissions especially if they've offered places on courses with little connection to the UK job market.

And students? They're stuck in limbo - between planning their futures and worrying about policies that could change midway through their studies.
